Training and Placement Cell at Faculty of Law, University of Lucknow, is being established to play a vital role for the training and placement of the students in the institute. With the recent increase in the likelihood for law as a career, competition for employment is increasing every day and placement has become a challenging task. A full fledged placement cell is being established in our college with the support of senior teachers and students for this purpose. Our Training and Placement Office is performing the following activities:-

- **Arranging training (internship) for students.**
- **Inviting various organization i.e. law firms and government organisations for campus recruitment.**
- **Personal training and career planning to fulfil various needs required in the legal field today.**

For placement, a large number of prospective employers are being contacted and efforts are being made to invite those firms to visit our faculty and to conduct campus recruitments. The objective of the Training & Placement Cell is to look for a 100% employment. The Cell is assisted by student placement coordinators who lead a team of placement representatives from various courses of study. The Training & Placement Cell shall ensure and take care to provide the best arrangements and hospitality for the visiting firm officials.

The **Training & Placement Cell** would provide for all audio visual facilities, for PowerPoint Presentations, written test, group discussion and interviews. It shall play a very important and key role in counselling and guiding the students of the University for their **Successful Placement** which is a crucial interface between the stage of completion of academic program of the students and their entry into the suitable employment. This cell shall also coordinate various activities related to the career of the students along with the internships.

TRAINING AND PLACEMENT ACTIVITIES

GENERAL OVERVIEW OF TRAINING & PLACEMENT CELL

The Training & Placement Cell is committed to provide all possible assistance to the students of the faculty in their efforts to find employment and internships. This commitment is demonstrated by the existence of a full time professor in charge. The Training & Placement service would operate year round to facilitate contacts between companies and graduates. Staffs are available to respond to student's question and concern of all kinds. This may include advice on placement procedures, help with preparation of applications and resumes and practice for interviews. The aim is to ensure that students have the information and skills necessary for an effective job search. All advice is based on up-to-date placement statistics and an envisioned view of future and educational and legal trends. Every effort is undertaken to create opportunities for our students to get placements. We hope to reach maximum placements level in the years to come.

PLACEMENT FACILITIES

- **Separate cell has been established with one full time staff incharge for placement.**
- **Guide students to approach companies and firms.**
- **Survey on recruiters' expectations from students.**
- **Alumni networking.**
- **Organizes training sessions on skill development .**

SUMMER TRAINING

Each student is expected to undertake summer training in companies of repute for duration of 3-4 weeks, as part of course curriculum. Students are required to work on a project given to them either by the organisation or selected by students themselves. The project report is an intensive learning exercise for students to apply particular theoretical concepts into practical situations as experienced in the real world. Final placement of students is a strategic activity for the university and all the processes are aligned for the same. Keeping in mind the existing and expected job opportunities, we plan to provide placement services to our students. For effective placements, we establish close ties with the companies, which are in the process of providing jobs to our students. The existing placement cell keeps intensive interface with leading corporate/government organisations for the same.
