- The entire paper (title, abstract, keywords, main text, figures, tables, references, etc.) must be in ONE document created in MS WORD (Compatible Mode). Font used should be Times New Roman and font size should be 16 point (bold) for the paper title, 14 point (bold) for the main heading, 12 point for rest of the text. Please provide margin of 1" on all sides with 1.5 line spacing. The text should be justified.
- References should be provided using American Psychological Association (APA) Style-sheet.
- Kindly ensure the location and placement of all the data tables, figures so as to get a correct blue-print.
- Changes in the paper title, abstract, authorship, and actual paper will not be entertained after the submission deadline i.e. January 10, 2018.
- Submitted papers must not have been previously presented, published or accepted for publication.
- Paper should be accompanied with duly filled registration form and a copy of bank receipt. No paper will be processed without payment of registration fee within time limit.
