- 2. Tender form shall be sold to working Contractors of UPSRTC on Producing the Experience, Signed by the Officer not below the rank of Executive Engineer as per Experience conditions.
- 3. Experience Certificate to be attached and should be Signed by the Officer not below the rank of Executive Engineer as per following conditions(For all Contractors):-

- 4. Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices by the Central Government, the State Government or any public undertaking, autonomous body, authority by whatever name called under the Central or the State Government. (Affidavit attached compulsory).
- 5. Any bidders having Criminal record is not allowed to participate in the bidding process. Any person who is having criminal cases against him or involved in the organized crime or gangster activities of Mafia or Goonda or Anti social activity are strictly prohibited to participate in the bidding process. If it is established that any bidder has criminal record, his bid shall be automatically cancelled. (Affidavit attached compulsory).

- 6. For works above 5.0 lakhs, Bidders shall submit the Income tax return of last three financial years.
- 7. If any on going work of tenders is more than 15% behind the schedule due to the fault of the contractor at a stage when 50% time period from the date of start has passed then that tenderer shall be disqualified from the process of opening of price bid. (Affidavit Compulsory)
- 8. Any Bidder who is registered with the Bar Council is not allowed to participate in bidding process.
- 9. The Tenderer(s) must submitt performance Security as per Annexure-1 at the time of Agreement.
- 10. Attested copy of the partnership deed if it is partnership firm and registration certificate in case of company, sole proprietorship declaration in case of proprietorship firm. Joint ventures shall not be accepted.
- 11. Each tender must be accompanied by carnest money as shown above against each item—failing which tender may not be considered. Earnest money may be either in shape of N.S.C./ CDR/FDR duly pledged to authority of Executive Engineer Building Division—(East) U.P. State Road Transport Corporation, Lucknow.
- 12. The CDR and FDR should invariably be from a nationalized/Schedule bank. The CDRS FDRS—from a limited bank shall in no case be entertained.
- 13. In the event of the Tender submitted by a Partnership firm must be signed separately by each member thereof or in the event of the absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing to do so.

- 14. Other conditions of the contract and blank forms of contract ic, complete tender documents—can—be obtained from the office of the undersigned on any working day during office hours on—payment as shown above against each item.
- 15. In case the person/firm whose tender is accepted, fails to sign the contract documents—with in the period as stipulated in the acceptance letter or 15 days, which ever falls later, the earnest money deposited by him/them, shall be forfeited without any further intimation in this regard and the acceptance shall be accordingly withdrawn.
- 16. The accepting authority shall have the right of rejecting all or any of the tenders...
- 17. Security money will be refunded after 6 months (one year in the case of overhead tank sand tube-well works) from the date of completion of the work provided no defects are found during the maintenance period.
- 18. Tendered rates shall remain valid for the purpose of entering in to agreement for three month from the date of tender and no claim for the fluctuation in labour or market rates will be admitted.
- 19. Each tender must be accompanied with a non judicial Stamp paper of Rs. 100/- duly typed/ pasted as per format attached and signed on revenue stamp of Rs. 1/- for the validity of the Rates.
- 20. Tender should be filled in Devnagri (Hindi) or in English clearly both in words and figures, every correction made must be initiated properly prior to submission of tender. Overwriting is strictly prohibited and on every place in tender form cutting must be initialed.
