The College Principal after verifying eligibility are requested to forward the details of teachers to the Head of the concerned Departments in the University who after checking the eligibility criteria will send it to Prof. Anil Mishra, Coordinator, U.G./P.G./Ph.D. Admissions 2017.

ELIGIBILITY CRITERIA OF SUPERVISOR

(Proposed, subject to approval of Honourable Chancellor)

- 9.2 Any regular Professor of the University with at least five research publications in refereed journals and any regular Associate/Assistant Professor of the university/ College with a Ph.D. degree and at least two research publications in refereed journals may be recognized as Research Supervisor. Provided that in areas/disciplines where there is no or only a limited number of refereed journals, the University may relax the above condition for recognition of a person as Research Supervisor with reasons recorded in writing.
- 9.3 Permanent teachers substantially appointed in a specific Department who have a proven track record of research, as evidenced by publications in peer-reviewed journals, working in a Government or Government aided Associated college of the University of Lucknow and fulfilling all the requirements of clause 9.2 of this ordinance will be allowed to act as a Ph.D. supervisor. In case of the Science subjects, the supervisor will have to provide evidence for having sufficient laboratory facilities for carrying out the proposed research work. At any given time, Associate Professor will be eligible to supervise maximum four Ph.D students while Assistant Professor will be allowed to supervise maximum two students at a time. The admission of students will be done as per the University admission process.
- 9.3.1 The College teacher (Associate Professor/Assistant Professor) who wants to be Ph.D. supervisor is required to send a proposal mentioning the area of research and proposed task, the proposal duly recommended by the Principal of the college, promising that the necessary facilities required for research are available at the Department/College.
- 9.3.2 The eligibility of research supervisors would be decided by the DRC of the concerned department as per the UGC regulations/Gazettes. The framework of the university of Lucknow Ph.D ordinance would be the guiding regulations for all other matters.
