विषय : शोध पर्यवेक्षकों के सम्बन्ध में।

महोदय/महोदया,

कृपया लखनऊ विश्वविद्यालय, लखनऊ पीएच0डी0 अध्यादेश-2018 के बिन्दु-5 तथा 9 का संदर्भ ग्रहण करने का कष्ट करें, जो निम्नवत् है :-

5. **Allocation of Research Supervisor, Eligibility criteria to be a Research Supervisor, Co-Supervisor, Number of Ph.D. scholars permissible per Supervisor, etc.-**

- 5.1 Any regular Professor of the University with at least five research publications in refereed journals and any regular Associate/Assistant Professor of the University with Ph.D. degree and at least two research publications in refereed journals may be recognized as Research Supervisor.
- 5.1.1 Provided that in areas/disciplines where there is no or only limited number of refereed journals, the University may relax the above condition for recognition of a person as Research Supervisor with reasons recorded in writing.
- 5.2 Only a full time regular teacher of the University can act as supervisor. The external supervisors are not allowed. However, Co-Supervisor can be allowed in inter-disciplinary areas from other departments of the University or from other related institutions with the approval of the Departmental Research Committee.
- 5.3 The allocation of Research Supervisor for a selected research scholar shall be decided by the Department concerned depending on the number of scholars per Research Supervisor, the available specialization among the Supervisors and research interests of the scholars as indicated by them at the time of interview/viva voce.
- 5.4 In case of topics which are of inter-disciplinary nature where the Department concerned feels that the expertise in the Department has to be supplemented from outside, the Department may appoint a Research Supervisor from the Department itself, who shall be known as the Research Supervisor, and a Co-Supervisor from outside the Department on such terms and conditions as may be specified and agreed upon by the consenting Institutions/Colleges.
- 5.5 A Research Supervisor/Co-Supervisor who is Professor, at any given point of time, cannot guide more than Eight (8) Ph.D. scholars. An Associate Professor as Research Supervisor can guide up to a maximum of six (6) Ph.D. Scholar and an Assistant Professor as Research Supervisor can guide up to maximum of four (4) scholars.
- 5.6 In case of relocation of an Ph.D. woman scholar due to marriage or otherwise, the research data shall be allowed to be transferred to the University to which the scholar intends to relocate provided all the other conditions in these Ordinances are followed in letter and spirit and the research work does not pertain to the project secured by the parent institution/supervisor from any funding agency. The scholar will however give due credit to the parent guide and the institution for the part of research already done.




**9 Academic, administrative and infrastructure requirement to be fulfilled by colleges for getting recognition for offering Ph.D. programmes.-**

- 9.1 Colleges may be considered eligible to offer Ph.D. programmes only if they satisfy the availability of eligible Research Supervisors, required infrastructure and supporting administrative and Research Promotion facilities as per these Ordinances.
- 9.2 Post Graduate Departments of Colleges, Research laboratories of Government of India/State Government with at least two Ph.D. qualified teachers/Scientists/other Academic staff in the department concerned along with required infrastructure, supporting administrative and research promotion facilities as per these Ordinance, stipulated under sub-clause 9.3, shall be considered eligible to offer Ph.D. programmes colleges should additionally have the necessary recognition by the Institution under which they operate to offer Ph.D. programme.
- 9.3 Colleges with adequate facilities for research as mentioned below shall offer Ph.D. programmes.
- 9.3.1 In case of Science and Technology disciplines, exclusive research laboratories with sophisticated equipment as specified by the institution concerned with provision for adequate space per research scholar along with computer facilities and essential software, and uninterrupted power and water supply.
- 9.3.2 Earmarked library resources including latest books, Indian and International Journals, e-journals, extended working hours for all disciplines, adequate space for research scholars in the Department/Library for reading, writing and storing study and research materials.
- 9.3.3 Colleges may also access the required facilities of the neighbouring Institution/colleges, or of those institutions/colleges/R & D laboratories/ Organizations which have the required facilities.

- (iii) विषयगत सूचना से सम्बन्धित जो शिक्षक पी0जी0 पाठ्यक्रमों में अध्यापन कर रहे हैं, उस विभाग में कार्यरत शिक्षकों की कुल संख्या।
- (iv) लखनऊ विश्वविद्यालय शोध अध्यादेश-2018 के नियम-9 के अनुसार पीएचडी0 पाठ्यक्रमों को संचालित करने के लिए महाविद्यालय में उपलब्ध शैक्षणिक, प्रशासनिक तथा अवसंरचनात्मक व्यवस्था की उपलब्धता। कृपया विस्तृत विवरण उपलब्ध कराने का कष्ट करें।
- (v) उक्त शोध अध्यादेश के प्राविधान में अंकित व्यवस्थाओं के अनुसार पूर्व के शोध पर्यवेक्षक शिक्षकों तथा जिन नये शिक्षकों को शोध पर्यवेक्षक बनाया जाना है, उनकी सूचना सम्बन्धित शिक्षक की अर्हता के विवरण तथा तत्सम्बन्धी अभिलेखों की प्रमाणित छायाप्रतियों के साथ।
- (vi) पूर्व के शोध पर्यवेक्षकों के अधीन शोधार्थियों की संख्या तथा उनके अधीन रिक्तियाँ यदि कोई है, तो उसका विवरण।
