1. Article Writing Competition

▪ Topics-

- Constitutional validity of Unlawful Activities Prevention and Amendment Act 2019
- Appointment of Judges in Higher Judiciary
- Power of Governor in calling to form government whether discretionary or not
- Uniform Civil Code
- Position of Indian Economy in Global World
- Individual Rights v/s Minority Rights

▪ Rules-

- Article can be both in English or Hindi
- Co-authorship is allowed upto 1
- Participants shall mail the soft copy of Article along with the details and fee receipt of registration on rusinghlkouniv@gmail.com
- Article shall be of 1000 words maximum.
- Participants shall their Article latest by 13th September 2019

2. Debate Competition

▪ Topic

क्या सांसद या विधायक को किसी भी समय इस्तीफा देने की शक्ति है: कर्नाटक संकट

▪ **Rules-**

- There shall be a team of 2 students
- One shall speak for the motion and other shall speak against the motion
- There shall be 2 rounds- prelims and finals.
- Each participant shall be given 4 minutes maximum in the prelims and 5 minutes maximum in the finals (Excluding the cross questioning).
- There will be no cross questions in the prelims but in the finals cross questioning is allowed
- Prelims of Debate shall be conducted on 20th September 2019 in the Faculty of Law University of Lucknow from 2:30 pm and final round shall be conducted on 21st September 2019 from 11 am.
- Participants have to register themselves prior to the conduct of debate on or before 17th September 2019.

3. Poster Making Competition-

▪ **Topic- Position of India in Global World**

▪ **Rules-**

- Each participant has to make poster on chart and directly submit it latest by 17th September 2019 in the Faculty.

4. Legal Quiz-

▪ **Rules-**

- Each team shall comprise of 2 participants
- Questions will be asked from Constitutional Law, IPC, Family Law, Jurisprudence, Contract Law
- Quiz shall be conducted on 20th September 2019 at Juris Hall from 10:30 am. Teams shall report latest by 10:00.

5. Bill Drafting-

- Bill drafting can be on any issue related to which any bill has not been presented in Parliament
- Coauthorship is allowed upto 1.
- The draft legislation must be written in English only.
- The draft legislation shall be adjudged on the basis of the political viability, effectiveness, technique, research and pragmatism, all judged equally.
- The submission must be original. No part of it should have been published earlier nor should it be under consideration for publication elsewhere. Plagiarism of any sort will result in immediate disqualification.
- The draft legislation must be submitted in .doc/.docx format only with 12 pt font size, Margins (Top, bottom, left, right) should be of 2.54cm, justified alignment and 1.5 line spacing in Times New Roman Font.
- Submission shall be made on rusinghlkouniv@gmail.com along with the fee receipt and details.

6. Socio-legal film making competition-

Team can be maximum of 20 members. All the students shall be from the same college

- Film can be made on any issue.
- It shall be uploaded on you tube and its link shall be sent to rusinghlkouniv@gmail.com along with the fee receipt and details.
- No part of the film shall be copied. It shall lead to disqualification.
- Certificate & Trophy shall be given to the team.

7. Judgment Writing

Fact sheet-

1. In the state of Gotham, district Rasaul, there were several villages named Bilaspur, Hardaura, Pakdi, Ramnagar etc., in which Ramnagar was one of the populated village.
2. Singh family was the richest family of the village having maximum land. Mr Singh was having 2 sons Rakesh & Ravi. Despite of several efforts by Mr Singh Rakesh and Ravi did not worked together. Mr Singh did will of his property.
3. Both Ravi and Rakesh claimed that the will was in their favour respectively. On 02.04.2017 a civil suit was filed by Rakesh against Ravi elder brother of him for the title of the ancestral land of their family. The case was still pending in the Rasaul district court. Both of them had given threat to kill each other.
4. One day early morning on 07.06.2019 Ravi with some of his friends (Manish, Guddu, Vishal, Rajesh and Sintu) went to dig the boundaries of the said land along with kudari, belcha, lathi in their hands without informing his younger brother. When Rakesh came to know about it from one of the villager he then took few of the villagers with him named (kapil, Sonu, Dhananjay and Dinesh) with kudari, lathi and fawda to stop him from doing so.
5. When Rakesh with other villagers reached at the land he saw that Ravi was digging the boundaries of the said land and others were helping him. He shouted from a distance to stop him and when they both came infront of each other, a heated argument started between both of the party and they started to push each other.
6. The heated argument resulted into a fight and blow of lathi was used from both the side. One of the villager named kapil felt down due to the blow of lathi on the head by Ravi which resulted into his death.
7. One of the villager went to inform the Ramnagar police station and the FIR was registered .The I.O. came on the spot for investigation and evidence and all the lathi, fawda and kudari was taken into custody as evidence.
8. Ravi along with his friends were arrested under section 120(B), 302, 320, and 34.

9. The case went to Sessions Court for trial and the trial court convicted all of them under the said sections.
10. They filed an appeal in the Hon'ble High Court of Madras against the order of the session court.
