- b. Admit Card of UPCET-2021 if admit card is submitted at counselling centre, then photocopy of the admit card.
- c. Original Certificate of High School ( for proof of the age).
- d. Original mark sheet of qualifying examination (10+2)/ Diploma in Engineering/Graduation.
- e. Original Character Certificate in the prescribed format issued by Head of the Institution last attended.
- f. Original Transfer /Migration Certificate from the Institute last attended.
- g. Category Certificate (If opted for reservation).
- h. Sub Category Certificate, if applicable.
- i. Weightage Certificate, if applicable.
- j. Medical Certificate on the prescribed format of UPCET-2021.
- k. Income Certificate from those candidates whose parent's/guardian's annual income from all sources is Rs.2,00,000=00 (for GEN/OBC/Minorities) and Rs. 2,50,000=00 (for SC/ST).
- l. Receipt of fee deposited at the time of counselling.
