**Memorandum of Understanding between

An MoU has been reached on 27 day of June, 2019 between the **University of Lucknow** (hereafter referred to as the University) and **Jaganlite India Pvt. Ltd.**, Regd. Off.: 509/151, New Hyderabad, Lucknow-226007 (hereafter referred to as the Industry Partner) with respect to supporting the **M.Sc. Renewable Energy/B.Voc. Renewable Energy Technology Programme/Suryamitra/Varunmitra Skill Development Programme** of the University and activities of the University of Lucknow in solar and other renewable energy technologies.

I. Responsibilities of the University of Lucknow:

1. The University is running a M.Sc. Renewable Energy / B.Voc. Renewable Energy Technology Programme / Suryamitra / Varunmitra Skill Development Programme at the Centre of Excellence in Renewable Energy Education and Research located at the New Campus of the University of Lucknow.
2. The University also organizes the activities including exhibitions, workshops, seminars, conferences, consultancy services, etc. on Renewable Energy Technologies.
3. The University has expressed its interest to **Jaganlite India Pvt. Ltd.** to be the Industry Partner in its M.Sc. Renewable Energy/B.Voc. Renewable Energy Technology Programme / Suryamitra/Varunmitra Skill Development Programme and **Jaganlite India Pvt. Ltd.** have agreed to be the Industry Partner for this programme.

II. Responsibilities of the Industry Partner (Jaganlite India Pvt. Ltd.):

1. The Industry Partner will help the University in updating the curriculum and syllabus of the M.Sc. Renewable Energy / B.Voc. Renewable Energy Technology Programme from time to time as per the needs of the industry.
2. The Industry Partner will help the University in providing the Guest Faculty/Subject Expert for teaching and practical work in M.Sc. Renewable Energy/ B.Voc. Renewable Energy Technology Programme/Suryamitra/Varunmitra Skill Development Programme on payment basis as per the rules of the University/University Grants Commission.
3. The Industry Partner will help the University to provide Industrial Training/Field Visit of the faculty and students of M.Sc. Renewable Energy/ B.Voc. Renewable Energy Technology Programme/Suryamitra/Varunmitra Skill Development Programme as prescribed by the University from time to time.
4. The Industry Partner will help the University for the Project Work to be carried out by the students as may be prescribed by the University from time to time at the University of Lucknow or at the premises of the Industry Partner.
5. The Industry Partner will help the University in offering placement to the students after successful completion of M.Sc. Renewable Energy / B.Voc. Renewable Energy Technology Programme/Suryamitra/Varunmitra Skill Development Programme or train them to be mini or micro entrepreneurs in the field of Renewable Energy Technology.
6. The Industry Partner will also help the University of Lucknow to organize the activities including exhibitions, workshops, seminars, conferences, consultancy services, training programme etc. on Renewable Energy Technologies.

This MoU will be valid for a period of three years from the date of signing which may be renewed with mutual consent basis. The MoU may be terminated by giving three months notice in advance to the other party during the tenure of the MoU. In case of the breach of MoU by either party, the MoU will get terminated automatically.

Any dispute arising from the interpretation of this MoU shall be settled amicably by consultation and negotiation between the Signatories.
