Eligibility Criteria:

A student would be eligible for the aforementioned schemes, if

- 1. The total income of his/her parents or guardians does not exceed **Rs. 3 Lakh per annum**. For this purpose, applicant would have to produce an income certificate issued by the Tehsildar/competent authority.
- 2. Have clearly passed the previous semester or annual examination or is eligible for the back paper.
- 3. Is enrolled for the regular or self-finance courses of the university.
- 4. Has passed with *minimum 60% marks* in the previous examination.
- 5. Should have *at least 75% attendance* in the previous academic semester/year.
- 6. Should not have been involved in any unlawful activities. (A certificate issued from the Proctor office should be enclosed with the application).
- 7. He/She is not receiving any kind of financial assistance including fellowship/scholarship.
