### MoU for Academic and Scientific Cooperation

#### Purpose

The purpose of this agreement is to promote cooperation in pharmaceutical education and scientific research between Lifecare Innovations Pvt Ltd., Biotech Park, Jankipuram, Sector G, Lucknow, UP-226021, India, and the Institute of Pharmaceutical Sciences, University of Lucknow, Second Campus, Jankipuram Extension, Lucknow, UP-226031.

#### Type of Cooperation

5. Include collaboration in setting up and upkeep of the relevant Infrastructure in both the organization and other activities as mutually agreed.

This agreement places no financial obligations or supplementary funding commitments on either party


#### Terms

This agreement will become effective upon the date of signature by both parties. It shall remain valid for 3 years from the date of the signature, with the understanding that it may be modified by written mutual consent of both parties. This Agreement may be terminated by either party with the advance written notice of at least 30 days. Upon notice of termination both Lifecare Innovations Pvt Ltd., and Institute of Pharmaceutical Sciences, University of Lucknow agrees to work in good faith to enable visiting students to complete their respective training/ research programs unhindered by the termination. The Agreement may be extended by mutual consent of the two parties after the 3 years, and it must be renewed in written.

This Memorandum of Understanding is hereby signed in two (2) copies with one (1) copy remaining in the possession of each organization.




