This Memorandum of understanding is made on this 23rd day of September, 2021 between, University of Lucknow, Lucknow represented by Prof. Alok Kumar Rai, Vice Chancellor, University of Lucknow and the Youth wing of Maitri Bodh Parivar represented by Dixit Mehra, Director, YGPT, India Heart.

Between

Youth For Global Peace And Transformation (YGPT), the youth wing of MBPCT (Maitri Bodh Parivaar Charitable Trust), having its registered office at Maitribodh Parivar, No 1, SAI PRIDE CHS, Plot N0 219, Sector 21, Kamothe, Navi Mumbai, Maharashtra , India . 410209 through its Authorized Signatory (hereinafter called the 'First Party)

And

Happy Thinking Laboratory, Department of Psychology, University of Lucknow, Lucknow 226007, India, having its office at ONGC building in the main campus, located at University Road, Babuganj, Hasanganj, Lucknow, Uttar Pradesh 226007. University of Lucknow (LU) is a State University by statutory enactment to cater to the growing requirements of Higher Education across the country and abroad. LU desires to provide and inculcate in its students' values and inner development in order for them to perform better as students and be leaders for growth in nation building. LU has several affiliated colleges and institutes under its umbrella.

Established in 1929, **Department of Psychology** was the first department in the universities of Uttar Pradesh and third in India to offer Under Graduate and Post Graduate courses in Psychology. University of Lucknow, through its Authorized Signatory, hereinafter called the 'Second Party'.

The expressions of the terms the First Party and the Second Party wherever they occur in the body of this deed shall mean and include their respective heirs, executors, legal representative's administrators and assigns, unless and until it is repugnant to the context or meaning thereof.

WHEREAS the first party herein is a part of a charitable trust namely MAITRIBODH PARIVAAR duly regd. under the Indian Charitable Trust Act, and the first party is a socio-spiritual organization running programs and sessions for the development and transformation of youth and growth of the society. The second party herein is a newly established laboratory with a vision to empower the thoughts of youth to understand indigenous notion of happiness to build a world of peace, love and universal harmony by connecting science with spirituality. This laboratory is committed to provide services to the students of University of Lucknow through Counselling and Guidance Cell, LU.

Both the parties mutually agree to the collaboration to take sessions for the transformation and development of the students.

AND WHEREAS YOUTH FOR GLOBAL PEACE AND TRANSFORMATION (YGPT) signs this Memorandum of Understanding with Happy Thinking Laboratory, Department of Psychology, University of Lucknow, valid for a period of one year.

AND WHEREAS the said parties in order to honor their respective commitments towards each other therefore agree on the following agreed terms and conditions as envisaged herein:-

1. That the First Party shall conduct online/offline sessions as per modules already ready with them for the members of the Second Party with prior consent from the second party.


2. That the First Party herein, further agrees that it will conduct sessions for the students and staff members from 24th September 2021 to 23rd September 2022 for the students & staff members of the Second Party.
3. That the parties hereto further mutually agree that the Zoom link for the sessions and meetings will be created by the First Party only and the second party will be given the rights of co-host.
4. That further First Party mutually agrees that Data of participants will be collected by them through Google registration form and shared with the second party.
5. That the official Social media handles of YGPT will be shared with the students of the Second Party if they want to join YGPT for volunteering their events and activities with prior consent of the second party.
6. That further First Party is permitted to take the snapshots of Zoom sessions which can be posted on their Official Social Media handles tagging the Second Party.
7. That the second party is permitted to take the snapshots of title page and participants pics and will not record the sessions and make it you tube live .
8. That all the Certificates of participation will be given by the first party.
9. That the Appreciation letter to the resource person will be given by the Second party to the First Party.

Steering Committee

There will be a steering committee comprising of five members, two each from University of Lucknow and YGPT and Head/ Coordinator, Psychology Department, University of Lucknow. The committee will look after all proposals and other related issues.

1.1 Timeline of MOU

1. The above MOU will be effective for one year from the date of signing. The MOU will be periodically reviewed in a joint meeting to assess the progress

and development of the present programs and also to identify new areas for collaboration.


2. The MOU reflects the commitments of respective organizations to the terms and conditions mentioned in the MOU. This MOU shall be amended or terminated at any other time by either party provided that notice of termination or amendment is provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to be effective. Upon termination the provisions of this MOU and corresponding program, agreements shall continue to apply to ongoing activities until each is completed.

3. Terms


Both parties agree to the above in Principle subject to such other formalities required by the respective Governing bodies including the approval of competent authority. Financial details are to be worked between the two organizations program wise , with prior approval of Vice Chancellor, University of Lucknow.


