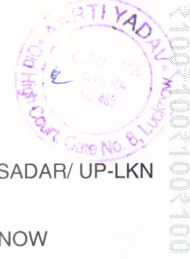

Areas of Collaboration:-



2. The trust will provide support to various departments in developing courses related to Indian cultures and performing arts.
3. Both organizations will develop value based courses.
4. The university will provide all infrastructural facilities required for the developing and conducting the courses.
5. The university will gradually develop partnership with other organizations for developing new vocational courses and ask for supporting funds.

6. Trust will conduct workshops, Seminars, Conferences on creative arts.

9. The trust will organize both faculty development programme (FDP) and executive development programme (EDP).

The MOU has been signed and declared with mutual consent between authorized signatory of trust and shall be effective for 5 years from the date of agreement and it can be renewable further for 5 years and so on.


The MOU can be terminated by mutual consent of trust and University.
