### NOTIFICATION FOR APPLICATIONS (FORM-III) FOR FILLING UP VACANCIES OF ANOS IN VARIOUS EDUCATIONAL INSTITUTIONS OF LUCKNOW UNIVERSITY, LUCKNOW

### LAST DATE OF RECEIPT OF APPLICATION: 09 JUN 2023

 Applications are invited for the post of ASSOCIATE NATIONAL CADET CORPS OFFICERS (ANOs) in the Senior Division in various Degree Colleges of the above university listed as <u>Appendix</u> to this Notification.

### 2. Eligibility Conditions for Senior Division (Permanent).

- (a) Permanent Lecturers/ Professor serving in existing NCC institution/ university to the Grade of Lecturer/ Asstt. Professor/ Professor etc teaching students of Degree Classes are eligible for selection and appointment of SD ANOs.
- (b) Workshop Instructors and Assistant Professors etc of Technical existing NCC Institutions/ University are also eligible for appointment as Senior Division ANOs provided they are imparting technical education to the students of Degree Classes and above or it's equivalent technical courses.
- (c) PTIs, Yoga Teacher, DPEs and Demonstrators are also eligible to become ANOs in the Senior Division in the existing NCC institution/university etc, provided they are working in the Grade of Lecturers and they are permanent member of teaching staff. Certificate in this regard from the Principal/VC to be attached (Proforma enclosed).
- (d) Contractual/ Short Term/ Seasonal or equivalent Lecturer/ Asst Professor/ Professor etc are not eligible for appointment as ANOs.

The Pay scale of the candidates will also determine whether he is eligible or not Pay Scale/ Pay Band/ Pay Matrix Level (Not Basic Pay) should be mentioned clearly in red ink on the top right hand corner of Form-III. The applications of the candidates whose pay scale are not mentioned in Form-III will be summarily rejected.

- 3. ELIGIBILITY CONDITIONS FOR TEMPORARY/ AD-HOC LECTURER/ ASST. PROFESSOR/ PROFESSOR ETC. AND EQUIVALENT, TEACHING TO DEGREE CLASSES.
  - (a) Temporary Lecturer/ Professor working in the Grades mentioned in Para 2 above are also eligible for appointment as ANOs in the respective Division provided a certificate from the Principal/ VC of the institutions is enclosed with application stating that the candidate is expected to continue for more than three years and is likely to be made permanent.
  - (b) Lecturer/ Asst. Professor/ Professor etc. appointed on Ad-hoc basis in the Grade mentioned in Para 2 above are also eligible for appointment as ANOs in the respective Division provided a certificate from their Employer (and NOT from the Principal/ VC of the institution) is enclosed alongwith the application stating that the candidate is expected to continue for more than three years and is likely to be made permanent. Such candidates will also have to sign a DECLARATION AS UNDER and enclose it with application.

"THE UNDERSIGNED UNDERTAKE THAT IN THE EVENT OF MY TERMINATION FROM SERVICE AS AD-HOC LECTURER/ PROFESSOR FROM MY INSTITUTION, I WILL HAVE TO RELINQUISH THE COMMISSION AS ASSOCIATE NCC OFFICER".

- 4. The vacancies must be of the boys (mixed) Bn of the Senior Division/Wing and not from the Girls Unit/ Bn. The male/ female candidates both can be applied against the vacancy of the mixed Bn.
- 5. The vacancy of the institution other than ibid university Division/Wing should not be considered/ included.

- The selection of candidate in respect of Army, Navy & Air Wing should be selected by a different Board of Officer and not to be clubbed in the single board proceeding.
- 7. The selection of a candidate will be valid till the time of existing policies issued time to time. The selected candidate must complete their requisite course/ appt as ANO within the selection validity period, failing which the same automatically will be treated as cancelled.

### 8. AGE LIMIT FOR CANDIDATES.

- (a) Candidates applying for Senior Division ANOs should not be below 21 years of age and should not be above 45 years of age on 09 Jun 2023 i.e. last date of receipt of application.
- (b) The upper age limit as relaxable, with a provision for further 3 years i.e. upto 48 years of age is at the sole discretion of the DGNCC. No further relaxation will be provided.
- (c) CTCs of High School Certificate are required to be enclosed alongwith the application form as proof of age.
- (d) CTCs of the appointment letter, Highest Educational Qualification Certificate, Professional Certificate if any, and Current Pay Certificate including Pay Scale issued by the Principal/ VC etc. must be attached with application form-III.
- (e) SOC in r/o Age Relaxation Cases duly recommended by Chain of Command must be forwarded by Unit/ Gp HQ to this HQ by 09 Jun 2023 without fail (in triplicate).
- (f) Medical must be done between issue of notification date and last date of receipt of application by a Govt Medical Officer or Registered Practioner. The format is as under: -

- (f) Certified that "Vacancy of SD ANO being subscribed is as per authorization i.e. from the institution which has been allotted NCC Coy but not less than 50 cadets" is enclosed.
- (g) Authentication sheet as per format to be att with Form-III.

### 9. OTHER CONDITIONS FOR ELIGIBILITY/ APPOINTMENT.

The candidate applying for Senior Division should be:-

- (a) A citizen of India or a subject of Nepal.
- (b) Medically fit. A certificate to this effect should be given by the medical practitioner in the requisite column of the application form.
- (c) Having good moral character,
- (d) Should not have been dismissed earlier from NCC ITF, TA, or the Armed Forces.
- (e) Should not be a member of any communal/ political organization.

### 10. HOW TO APPLY.

- (a) Applications Form-III duly filled and recommended by the Head of the institution should be submitted to the respective NCC Unit well before the last date of receipt of applications. The unit will forward the same to Group Headquarters.
- (b) It should be ensured that the requisite certificates mentioned in various Paras of this "NOTIFICATION" are enclosed with the application.
- (c) Applications not found in order or without the requisite documents will be summarily rejected.

### 11. IMPORTANT ASPECTS.

(a) While making entries in application forms, it should be ensured that the date of filling up the application forms-III by the candidates and dates of making entries by the VC of the institutions, medical officer, unit and the Group HQ should be between 10 May 2023 (date of the issue of Notification) to 09 Jun 2023 (Last date of

receipt of applications). The applications not processed between the above date will not be entertained. Please ensure that no column will be left blank. If not applicable NA must be written.

- Eligible candidates will be required to appear for interview before a selection board on a date to be notified later.
- (b) The selected candidates will have to undergo Pre-Commission Course of 12 weeks duration. However, candidates who have served in NCC earlier in the same Division or those who are in possession of 'C' certificates will undergo a 12 weeks PRCN (DC) Course:

- Documents for Grant of Commission in respect of Normal (d) ANOs (other than DC) would continue to be dealt with as hithertofore.
