- 2. The fund of Rs. 14,60,000/- (Rupees Fourteen Lakhs Sixty Thousands only) will be released in two or more instalments to University of Lucknow through the State Office, KVIC, Lucknow based on progress of the project of which 1<sup>st</sup> instalment of Rs. 12,00,000/- (Rupees twelve lakhs only) will be released. The Institute shall complete the entire project within a period of one year from the date of the receipt of the funds from KVIC.
- 3. While implementing the project the following points to be taken into consideratio9n and included in the final report
  - i. It is suggested to include comparative study with standard parameters as per Pollution Control Regulation, as well as scope of its application in the Khadi and Leather Industries.
  - ii. Further, it is suggested to coordinate with KNHPI, Jaipur to collect samples, data and facts related to HMPI Sector units.
  - iii. The machineries required for the treatment of effluent from HMP units, process parameters also to be stated.
  - 4. It is requested to ensure the following points while implementing the project:
    - a. The compliance of required formalities, and send the quarterly progress report of the project on regular basis as per Annexure-IV and a copy endorsed to the State Office, KVIC, Lucknow.
    - b. Sanctioned budget is to be utilised as per the need and rate of reasonableness of all expenditure following guidelines issued by KVIC time to time as well as the provisions of the GFR. No additional expenditure shall be provided over and above the sanctioned amount, i.e., Rs. 14,60,000/-. After completion of the project, unspent balance amount shall be refunded to KVIC.
  - 5. After completion of the project, a list of all the machineries/equipment procured and prototype developed out of the sanctioned amount shall be provided to this Directorate along with the final project report. All such machineries/ equipment/ prototype will be the property of KVIC and the Director, State Office, KVIC, Lucknow will be the custodian.
  - 6. As per existing guidelines, University of Lucknow, Lucknow shall execute an Agreement in the prescribed format is enclosed at Annexure A. The Agreement should be on non-judicial stamp paper of proper value as per the State Government norms.
  - 7. The Project Investigator shall protect the outcome of each project through the suitable provisions of IPR, i.e., patent, brand name, copyright, trademark etc. The patent, copyright will be jointly filed in the name of the Chief Executive Officer, Khadi and Village Industries Commission, Mumbai and the Head of the Institute of the Implementing Agency. The Project Investigator and the Co-Project Investigator will be inventors of the technology.

This agreement is made at ..... \_\_\_\_\_day of two thousand twenty between Chief Executive Officer Khadi and Village Industries Commission having its Central Office at 'Gramodaya' Irla Road ,Vile-Parle (West) Mumbai- 400056 hereinafter referred to as ' KVIC ' [ which expression shall unless repugnant to the subject or context include its successors-ininterest and assigns] and represented by **State Office**, **KVIC**, of one part; And The.....(the Institute) an Institution set up by the Government of India under the C/0 (Address of Implementing Agency) hereinafter referred to as 'the Institute' ( which expression shall unless repugnant to the subject or context include its successors-in-interest and assigns ) and represented by its Secretary, Director, Dean, \_\_\_\_\_, of the other part. Whereas the **KVIC** is desirous of sponsoring of ......project for "as per the sanction letter vide no ...... (Copy attached, which will form part of this agreement) " (Name of the ......Projects sanctioned)(hereinafter referred to as the research projects. And whereas the Institute has agreed to undertake the said project on certain terms and conditions as hereinafter appearing which the **KVIC** and the Institute have mutually agreed to.

Now the indenture witnesses and is hereby agreed by and between the parties hereto as follows:-

- 2. The **KVIC** shall release the aforementioned amounts to the Institute in suitable installment. The first full amount of Rs. ..... lakhs (Rupees ...... lakhs only) shall be released on the execution of this agreement and subsequent release shall be made in suitable installments only after assessment of the progress of the project/scheme by the **KVIC** according to the terms and conditions of this agreement by the Institute.
- 3. The Institute agrees to undertake the said project for the period of one year (no. of Years/ months) from the date of receipt of the first installment. The Institute shall complete the entire research project within a period of one year from the date of the receipt of the funds from the **KVIC** and give the comprehensive result of the same and time being the essence of this contract.
- 4. The Chief Executive Officer (CEO), KVIC shall depute his/her representative or officials to assess the progress of the work of the research project/scheme from time to time. In the event of unsatisfactory progress in the work of the research project/scheme of which the CEO, KVIC or its authorized representative shall be the sole judge to decide and the KVIC shall be at liberty to discontinue the research project upon giving

notice .....(Name of the Institute) to (Institute name) shall have a period of 30 days from the date of receipt of notice of the defect or delay to cure the **unsatisfactory** progress of work. Should .....fail to cure the defect or complete that unsatisfactory progress, KVIC may terminate this Agreement without further notice. In such an event, the.....shall be bound to refund the entire amount released by KVIC within 30 days. Thereupon the **KVIC** shall be at liberty to entrust the said research project/scheme to any other person, corporation or agency to conduct and carry the same afresh or to continue the same further from where the project was discontinued and for this purpose the **KVIC** shall be at liberty to utilize all data, reports techniques and materials used and returned by the Institute to the **KVIC** on termination of the project as aforesaid.

- 5. The Institute shall utilize the said amounts on the items as set out in the budget allocation and the Institute shall abide the condition[s], if any in the budget allocation letter. The Institute shall not seek any fund from any other agency for this project. Any unspent part of the amount would be refunded to the KVIC and carry forward of the fund for the next financial year would require a specific agreement between the parties.
- 6. The research project(s) shall be conducted under the coordination with **Director/Incharge (Science and Technology),of Khadi and Village Industries Commission (KVIC), No 03, Irla Road, Vile Parle (West) Mumbai-400056**.
- 7. The Institute shall submit the progress report from time to time [Quarterly Progress Report] about the achievement and progress made in the research project /scheme every three months during the course of the research/scheme in such Proforma as may be prescribed by the **KVIC**.
- 8. The institute is free to publish the results, procedures, method, data but it will acknowledge the **KVIC** for rendering the financial assistance. The institute shall take all measures to take the patent in consultation with the **KVIC**. The ownership of patent will be jointly by the **KVIC** and the Institute. The royalty of the invention also equally shared by the **KVIC** and Institute.
- 9. The Institute shall keep separate accounts of the amount paid by the KVIC money spent for the research project/scheme and shall allow the KVIC, its officials or auditors or statutory auditors appointed by the competent authority to inspect the said books of accounts and other registers and reports.
- **10.**The Institute shall send the details of the assets acquired mainly out of the grant from the **KVIC**, furnish the utilization certificate and audited statement of accounts pertaining to the grant received from the **KVIC**. If it is found expedient to keep a part/whole amount in bank account earning interest, the interest thus earned will be treated as a credit to the Institute to be adjusted towards installment of grant or to be returned to the **KVIC**.

- 11. The sale proceeds, if any arising directly out of the funds given to the Institute as a result of the development of the project/scheme, shall be remitted to the **KVIC**. The **KVIC** shall be at its liberty to allow a part of it to be retained by the Institute.
- 12. The Institute shall submit to the **KVIC** a list of assets created out of the grant given by the **KVIC** at the end of each financial year as well as at the time of giving further installment of grants.
- 13. All the assets acquired from grants will be the property of KVIC and Institution shall not create any charge and/or dispose off or utilized for the purpose other than whose for which the grant was given without the prior permission of the **KVIC**. On the completion of the project/scheme, the **KVIC** shall be at liberty to sell, otherwise dispose off assets or has the discretion to gift the assets to the Institute if it considers it appropriate.
- 14. The Institute shall refund the entire funds, in case the Institute is not in a position to execute or complete the project/scheme.

15. If a dispute arises out of or in connection with this contract/agreement, or in respect of any defined legal relationship associated herewith or derived therefrom, the parties agrees either to seek an amicable settlement of that dispute by conciliation under the ICADR Conciliation Rules, 1996 or to submit that dispute to Arbitration under the ICADR Arbitration Rules, 1996. The authority to appoint Conciliator/Arbitrator shall be the International Centre for Alternative Dispute Resolution.
