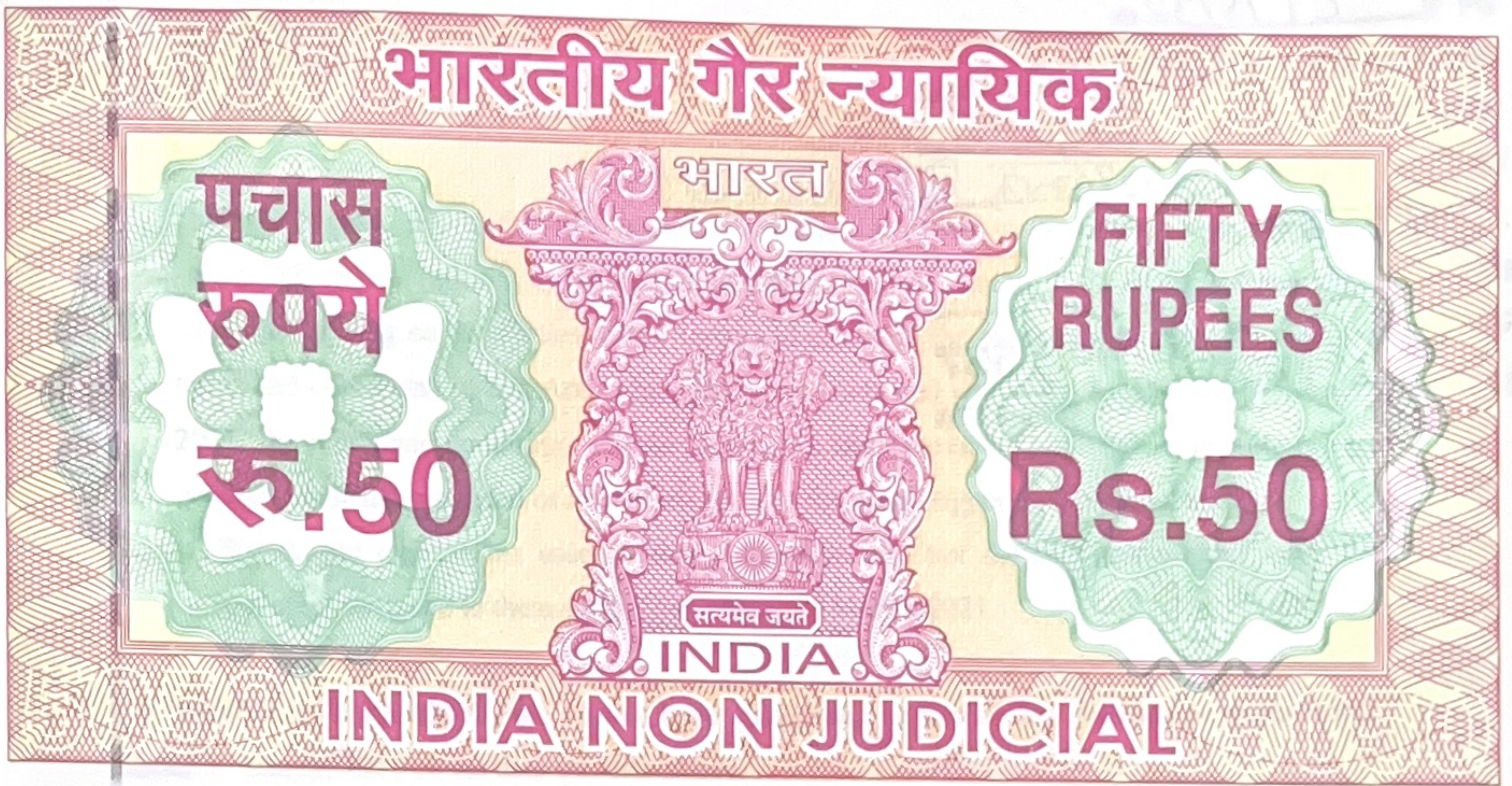

For the purpose of this MoU and brevity's sake each of the parties above is hereinafter referred to individually as a "Party" and both collectively as "the Parties". This Addendum to the MoU between the aforementioned parties is made on this ____ the day of March 2024, at New Delhi, India.

WHEREAS, MoU dated 3rd March, 2021 ("Original MoU") was executed between the Parties for collaborating, partnering and networking activities and providing need-based training support in implementing the activities as mutually agreed upon.

WHEREAS, the Parties after evaluating the results of the partnership solemnized through the Original MoU have decided to extend the Term of the Original MoU in accordance with the Clause 6 (ii) of the Original MoU. Hence, this Addendum to the Original MoU is executed between the Parties to record the changes as mutually agreed upon between the Parties. This Addendum shall be effective from the 3rd March, 2024 ("Addendum Effective Date").

NOW THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. The Clause 6 (i) of the Original MoU is hereby amended and shall now and hereinafter read:
"This MoU shall be deemed to have commenced w.e.f 3rd March, 2021 and continue for next 4 years till 2nd March, 2025. Either party can terminate the MoU by giving 3 months' notice in writing."
