



MEMORANDUM OF UNDERSTANDING
BETWEEN
UNIVERSITY OF LUCKNOW, INDIA
AND
TAJIK TECHNICAL UNIVERSITY NAMED AFTER ACADEMICIAN M.S. OSIMI

This is a Memorandum of Understanding (MoU) between University of Lucknow, India (hereinafter referred to as “University of Lucknow”) and the Tajik Technical University named after academician M.S. Osimi, Republic of Tajikistan (hereinafter referred to as TTU)

This MoU sets out the terms and conditions under which the two institutions have agreed to work together to promote academic and research cooperation. The spirit of this initiative is intended to develop a closer understanding, greater co-operation, and durable friendship between the two institutions.

In pursuance of this aim, both parties hereto agree as follows:

1. Terms and Conditions

- 1.1. The Memorandum of Understanding (MoU) essentially sets out the general nature of the co-operative agreement between University of Lucknow and the Tajik Technical University named after academician M.S. Osimi of Tajikistan. It is not intended that the agreement shall give rise to any legal rights nor obligations between the two institutions.
- 1.2. Neither party shall assume any financial obligations arising from the MoU, except as mutually agreed under separate schedules jointly established from time to time.
- 1.3. Specific projects which are encompassed by this MoU will be mutually agreed upon by both parties and will be subject to separate agreements.

2. The Goal

The intended goal of this MoU is to develop and maintain an ongoing relationship between the two institutions. The relationship will provide opportunities for institution members – academic and professional staffs – as well as students, to participate actively in the academic and research programmes of the two institutions.

3. Scope of Activities

Possible activities may include, but are not limited to, the following:

- (1) Joint research activities and publications
- (2) Joint participation in seminars and/or academic meetings, and
- (3) Joint academic programmes



- (4) Student and Staff Exchange
- (5) Internship for students



This MoU shall become effective on the date of signature by the representatives of the two institutions, and will be effective for a period of 2 (Two) years. The period of validity may be extended upon mutual agreement of the two institutions. Amendments to this MoU may be made upon mutual agreement of the two institutions.
