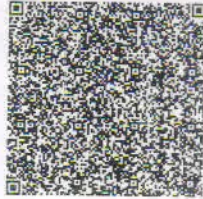

This **Memorandum of Understanding** is made on 3<sup>rd</sup> March, 2021 between **The University of Lucknow** which strives to be among leading educational institutions of the world by consistently engaging in its endeavour through quality teaching, research and innovation rooted in the Indian value system, and working towards building an intellectual infrastructure that serves the country, its society and humanity, having its office at University Road, Hasanganj, Lucknow, Uttar Pradesh - 226007 (hereinafter referred as **The University**) through its **Vice-Chancellor Prof. Alok Kumar Rai** which includes its successors, administrators and hereby assigns as **First Party**,

And

**Keystone Human Services International, India** hereinafter referred as **KHSI**, an organization working with people with disabilities and supporting them to live their best lives in the community and conducting trainings, educational events and providing technical support to NGOs, educational institutions, governments and other stakeholders having its operational office at M-8, Ground Floor, Green Park Extension, New Delhi – 110016, India represented through its **Authorized Representative Ms Elizabeth Pennock Neuville**, which includes its successors and hereby assigns as **Second Party**.

**WHEREAS** the esteemed University of Lucknow has created a value-added, elective course on Disability Studies and is being hosted within the Department of English and Modern European Languages. Dr Ranu Uniyal who is Faculty in the Department of English and Modern European Languages and is a graduate of "Social Role Valorization" course, and is working for a number of years on promoting and sharing strong foundations in creating a society where all people, including those with disability, have access to full and meaningful lives.

**WHEREAS** Keystone Human Services International has been working in India for the last few years by providing training, education, consultation and technical support to the NGOs, educational institutes, Governments, leaders & advocates and community homes in the country who are working in the field of disability. Also, KHSI India is working closely with



support activities to faculty, students and administration. Keystone is interested in assisting and strengthening the University of Lucknow in disability related studies, exchanging knowledge, sharing current practices and solutions of world level, awareness generation and technical support to faculty, students and administration. Keystone holds significant expertise in a number of areas pertaining to disability studies and can make numerous resources and expertise available through its courses, texts, writings, and faculty.

**NOW, THEREFORE, THIS AGREEMENT WITNESSES as follows:**

1. This Memorandum of Understanding sets the understanding for collaborating, partnering and networking activities and providing need-based training support in implementing the activities as mutually agreed upon. In the event of Keystone declining to continue the partnering, collaborating and networking activities, the University of Lucknow reserves the right to withdraw.

**2. Areas for Collaboration and Partnership:**

- i. Organizing training programmes, workshops, seminars and educational events for faculty, students and administration in orientation to values-based understanding of inclusive practice, the importance of valued roles, the social model of disability, autonomy and rights, and working with families.
- ii. Developing Courses and study materials for faculty and students on advanced learnings on "Social Devaluation and its Impacts" alongside the Department of English and Modern European Languages
- iii. Developing internship courses for the students of Social Work, Psychology and Disability Studies including field based visits and activities
- iv. Facilitating the access to International Experts on Disability issues for faculty and students of The University of Lucknow.
- v. Developing a trained brigade of young professionals in the University who would be ready to work in the field of disability, or enter their chosen profession with an excellent understanding of the issues, struggles, and gains made by people with disability in having access to inclusive, full lives.

- i) Both the parties will follow the broad guidelines of "Rights of Persons with Disability Act, 2016" and guidelines of Inclusive India Campaign.
- ii) The University of Lucknow in consultation with Keystone shall lay down necessary guidelines for use of logo of Keystone and The University in the programmes and areas where common effort is available. Similarly, brochure, factsheets, website shall also display common logo wherever applicable.
- iii) Keystone will not participate in any political activities.
- iv) Keystone will follow all the guidelines of NITI AYOOG of India.
- v) Keystone would generally cover the finances for the activities. However, Keystone may request financial support from the University in launching new initiatives or programmes. Also, the resources available with the University such as training halls, audio-video equipment etc. would be accessible to Keystone on request for conducting the activities.

#### **4. THE STAFF ARE NOT THE EMPLOYEES OF THE UNIVERSITY OF LUCKNOW:**

Keystone shall not represent itself, and shall ensure that its sub-contractors do not represent themselves as being employees of the University.

Keystone, working in connection with the work of The University of Lucknow shall not by virtue of this MoU be or for any purpose be deemed to be an employee of the University vice versa the employees of the University will not be considered as employee of Keystone by virtue of this MoU.

#### **6. TERM OF MoU**

- i. This MoU shall be deemed to have commenced **w.e.f 3rd March, 2021** and continue for next 3 years. Either party can terminate the MoU by giving 3 months' notice in writing on subject to the terms of MoU or the date of termination whichever is earlier.



## **7. DEFAULT**

If in the opinion of either party the partnership between The University and Keystone does not make satisfactory progress in the performance of its stated functions, the University or Keystone may

Terminate this MoU forthwith by giving a notice of three months by either side in writing.

## **8. INDEMNITY**

The University of Lucknow and Keystone, shall at all times, indemnify and keep indemnified each other against all actions, suits, claims and demands brought or made against it in respect of anything done or purported to be done by the other party in execution of or in connection with the services under this MOU and against any damage to each other in consequence to any action or suit being brought against Keystone and the University.

## **9. ARBITRATION**

In the event of any dispute between the parties, the same shall be referred to the sole arbitration of the Vice Chancellor of the University of Lucknow or any person nominated by her/him and the arbitration proceedings shall be held at Lucknow and the decision of the Sole Arbitrator shall be final and binding.

## **10. GOVERNING LAW / JURISDICTION**

This MOU shall be governed by and construed in accordance with the laws of India and shall be subject to the exclusive jurisdiction of the courts of New Delhi only.




