बैठक की कार्यवाही प्रारम्भ होने पर अध्यक्ष महोदय द्वारा समिति को अवगत कराया गया कि स्ववित्त पाठ्यक्रमों के फीस को युक्तिसंगत बनाये जाने के सम्बन्ध में डीन कमेटी द्वारा विचार किया गया था तथा अपनी संस्तुति दी गई थी। इसके प्रस्तुतीकरण के लिए बैठक में प्र० ए०के० सेनगुप्ता, अर्थशास्त्र विभाग, लखनऊ विश्वविद्यालय, लखनऊ को आमन्त्रित किया गया है जो एजेण्डा बिन्दु के समय इस सम्बन्ध में प्रस्तुतीकरण करेंगे, जिससे समिति को पूर्ण तथ्य स्पष्ट हो सके।

बिन्दु संख्या-1

वित्त समिति की गत बैठक दिनांक 15 मार्च, 2013 की कार्यवृत्ति एवं अनुपालन आख्या पर चर्चा के उपरान्त सर्वसम्मति से पुष्टि की तथा अनुमोदन प्रदान किया गया।

बिन्दु संख्या-2

(अ) लखनऊ विश्वविद्यालय द्वारा संचालित स्ववित्त पोषित पाठ्यक्रमों के शुल्क में आवश्यकतानुसार संशोधन के प्रस्ताव पर विचार-विमर्श कर समिति द्वारा संलग्नक-1 के अनुसार अनुमोदन प्रदान किया गया।

(ब) स्ववित्त पोषित पाठ्यक्रमों के संचालन हेतु विचार-विमर्श के उपरान्त निम्न बिन्दुओं पर भी सहमति प्रदान की गई।

1. Continuation of the programme to be allowed if the programme is generating enough resources to cover the cost of running the programme (including all costs).
2. The programme will contribute 40% of its total revenue to the University General Fund, 45% will be utilized for the payment to teachers/subject experts and non teaching and remaining will be utilized for recurring/non recurring expenditure and savings.
3. It will be expected from every programme which is revived that it will generate enough resources so that the total cost of the programme including investments deemed appropriate by the Department shall be covered within 60% of the revenue generated annually.
4. Every programme should have at least 20 admissions for continuation of the programme (except for Fine Arts). In case a programme has less than 20



admissions, the students shall be given an option to get transferred to another programme for which they fulfil the eligibility criterion and seats are available. In case a student is not interested in transfer to another programme, full fees shall be refunded.

5. For Quality Assurance and financial feasibility, every section of a programme should have a prescribed minimum of 40 and a maximum of 60 seats.
6. Rates for payment of honorarium to the teachers/subject experts for teaching the prescribed courses will be as follows, subject to availability of funds in the programme in the particular Academic Year :



E	Upto Rs. 20000	Rs. 300
D	Rs. 21001-40000	Rs. 400
C	Rs. 40001-70000	Rs. 600

7. Rates of payment for special lectures (not more than 20 lectures per annum or 10 lectures per semester) by eminent persons subject to availability of funds in the programme in the particular Academic Year :

Course Fee Range	Rates of Payment per lecture
Below Rs. 1,00,000 per annum	Rs. 1000 per 75 minutes
Rs. 1,00,000 and above per annum	Rs. 2000 per 75 minutes

8. The VC may designate one faculty as coordinator/in-charge of a programme. One person would be coordinator/ in-charge of only one programme.
9. All Professional programmes are expected to have an industry/Market interaction and placement plan.
10. Issues like inadequate infrastructure, absence/non-functioning placement cell, lack of field/industry visits, and lack of cultural programmes etc. in the campus were discussed. It was recommended that these anomalies be removed on a priority and provision be made for distribution of reading material to students in Professional courses. *Computer training shall be provided in professional courses.*
