**Table 1: Students feedback and Action Taken report**Based on the Students' feedback, appropriate changes were made as is notified in the following table:

S. No.	Feedback	Action Taken
1.	Course curriculum needs to be more flexible and there should be diversity in choosing the papers offered by the University. The papers should be so designed as to make students focus on their interest and relevant curriculum.	Syllabus was restructured by implementing the semester system in the UG programs and revising syllabi of some PG programs.
2.	Courses leading to employability and entrepreneurship may be added to the course curriculum.	More courses focusing on employability are included in the revised syllabi.
3.	Students suggested that syllabus of the programme should be in line with public/private sector requirements, further indicating towards syllabus modifications.	Need-based changes have been incorporated in the syllabus from time to time by adding optional/elective or specialized courses.

S. No.	Feedback	Action Taken
1.	There should be a good balance between theory classes and laboratory session in the course curriculum.	While revision of the syllabus it was ensured that there are courses of different kinds offering a balance between class and practical delivery.
2.	Regular assessments of students should take place including midsemesters as well as presentations for an engaging and enriching environment.	Semester system was implemented in programs at UG level, also ensuring regular assessment of students leading to an engaging environment.
3.	Teachers from others educational institution/ industries may be involved for their suggestions in syllabi upgradation.	At least one member from other educational institution was included at Departmental level in Board of Studies and opinion of subject experts from other bodies was solicited and considered in the syllabus revision process.
4.	Students should be encouraged to participate in group activities like field projects, internship, case studies, etc.	Group assignment or Project/ Dissertation was added as a part of course curriculum at PG and UG both level.
5.	Departmental activities may be evaluated along with regular performance assessment of faculties/ subject experts	Academic Audit/ Annual Performance Report is being conducted/assessed at University level with information from each Department level.


S. No.	Feedback	Action Taken

Based on the feedback received from the Students', appropriate changes were made as is notified in the following table:

S. No.	Feedback	Action Taken
1.	The students suggested that syllabus may be modified regularly keeping in pace with latest trends and should include new topics focusing on skill enhancement.	CBCS was implementing in all the PG programmes for giving the choice in selecting the courses. The courses based on skill enhancement are added in the revised syllabi.







